



DANVILLE BOARD OF FIRE AND POLICE COMMISSIONERS
Regular Monthly Meeting
September 4, 2018

THE REGULAR MEETING of the Board of Fire and Police Commissioners was called to order at 5:00P.M., by Chairman Linda Bolton at the Robert E. Jones Municipal Building, 17 W. Main Street, Danville, Illinois.

THE ROLL CALL was answered by Chairman Linda Bolton, Commissioners Frank Brunacci, Amy Hoose and Dr. Stephen Nacco; therefore, a quorum was present.

THE MINUTES of regular meeting held August 7, 2018 were presented. Commissioner Frank Brunacci moved for approval as presented seconded by Commissioner Dr. Nacco. On the voice vote, all ayes, no nays; the minutes are approved.

CORPORATION COUNSEL:

Counsel Wesner stated that the Union did offer to avoid a hearing and an agreement should be signed off soon. Commissioner Brunacci asked if the Board would know the reasons, and Counsel Wesner responded that the statement of charges will be withdrawn and the employee will serve a suspension of 10 days.

DEPARTMENT OF PUBLIC SAFETY:

Director Thomason said there is nothing new regarding the interviewing of Lateral Transfers. He then reviewed the Training Schedules for the new Police Officers, and followed up by saying he is authorized 64 on the staff and he now has 60.

The Director said the next thing to consider will be the upgrade testing process. The Chairman asked if that would be after the first of the year or in the Fall or what. A discussion then occurred regarding the time frame for the current eligibility lists, adding new Officers and promoting current Officers.


