Motion by Frank Brunacci and seconded by Linda Bolton to appoint Brandon Hahne as a Probationary Police Officer with an effective date of June 22, 2016 pending successful passing of the physical and psychological testing and background investigation. Motion approved 4-0.

The Board discussed the questions for oral interviews.

Motion by Carl Alexander and seconded by Linda Bolton to move into Closed Session to conduct oral interviews for Fire promotions. Motion approved 4-0. Moved into recorded Closed Session at 5:45 P.M.

Returned to Open Session at 8:15 P.M.
