




Zoning Map For:





The City of Danville Public Works staff has reviewed the proposals for demolition of the building at 101 W. Harrison. In review, it has become apparent that there are a few terms that need to be sorted out to arrive at the City's end goal for the site. As such, we are reaching out to the companies with the three lowest proposed prices and asking each to update the total proposal price with the following terms.

1. Contractor shall completely demolish and dispose of the building in accordance with City ordinances.
2. Contractor shall provide all trucking, cleanup, traffic control, safety measures, and equipment necessary to complete the work.
3. Contractor shall furnish, place, and compact CA-6 (or similarly graded natural stone or recycled material) backfill in 6" – 8" lifts to the satisfaction of the engineer. Compaction should be sufficient to achieve a 90% Standard Proctor density in all basements, pits, vaults, and excavations up to the existing surrounding surface grade. Contractor shall provide proof via a third party testing company that compaction methods used are adequate to achieve the desired results.
4. The final site condition shall be such that the surface is free of debris and is uniformly graded to surface drain. Minor surface variations up to 4" are allowed.
5. All dump fees shall be paid by the City; however, please note if there are special procedures you intend to utilize to recycle materials that may significantly reduce the amount of dumping fees required along with an estimated cost savings to the City.





1. To perform or be responsible for the performance of the following engineering services for the LA, in connection with the proposed improvements herein before described, and checked below:
  - a.  Make such detailed surveys as are necessary for the preparation of detailed roadway plans
  - b.  Make stream and flood plain hydraulic surveys and gather high water data, and flood histories for the preparation of detailed bridge plans.
  - c.  Make or cause to be made such soil surveys or subsurface investigations including borings and soil profiles and analyses thereof as may be required to furnish sufficient data for the design of the proposed improvement. Such investigations are to be made in accordance with the current requirements of the DEPARTMENT.
  - d.  Make or cause to be made such traffic studies and counts and special intersection studies as may be required to furnish sufficient data for the design of the proposed improvement.
  - e.  Prepare Army Corps of Engineers Permit, Department of Natural Resources-Office of Water Resources Permit, Bridge waterway sketch, and/or Channel Change sketch, Utility plan and locations, and Railroad Crossing work agreements.
  - f.  Prepare Preliminary Bridge design and Hydraulic Report, (including economic analysis of bridge or culvert types) and high water effects on roadway overflows and bridge approaches.
  - g.  Make complete general and detailed plans, special provisions, proposals and estimates of cost and furnish the LA with five (5) copies of the plans, special provisions, proposals and estimates. Additional copies of any or all documents, if required, shall be furnished to the LA by the ENGINEER at his actual cost for reproduction.

To pay for services stipulated in paragraphs 1a, 1b, 1c, 1d, 1e, 1f, 1h, 1j & 1k of the ENGINEER AGREES at **standard rates according to the attached Schedule of Charges for** actual cost of performing such work plus percent to cover profit, overhead and readiness to serve - "actual cost" being defined as material cost plus payrolls, insurance, social security and retirement deductions. Traveling and other out-of-pocket expenses will be reimbursed to the ENGINEER at his actual cost according to the attached Schedule of Charges. Subject to the approval of the LA, the ENGINEER may sublet all or part of the services provided under the paragraph 1a, 1b, 1c, 1d, 1e, 1f, 1h, 1j & 1k. **Provide Phase I Engineering Services** – Field Survey (ROW, Topographic, and Hydraulic), ROW or Easement Plats, Bridge Condition Report (BCR), Preliminary Bridge Design and Hydraulic Report (PBDHR), Environmental Study (ESR and PESA), Utility Coordination, and Project Development Report (PDR) according to the federal-aid requirements of the IDOT – Bureau of Local Roads and Street (BLRS) Manual, 2005 Edition (as updated on the IDOT website).

1. **Right-of-Way (ROW) Survey:**

The existing ROW and property lines will be established from approximately 500' west of the centerline of the existing bridge over Lick Creek to approximately 500' east of the centerline of the existing bridge.

2. **Topographic Survey:**

A Topographic Survey will be performed from approximately 500' west of the centerline of the existing bridge over Lick Creek to approximately 500' east of the centerline of the existing bridge. The bridge survey will be detailed due to anticipated reusing of the substructure elements. The limits of the topographic survey will be approximately 25' north of the north ROW line to approximately 25' south of the south ROW line.

3. **Hydraulic Survey:**

A Hydraulic Survey will be performed, according to the IDOT Drainage Manual, 2011 Edition, along Lick Creek from approximately 750' north (upstream) of the bridge to 750' south (downstream) of the bridge. Hydraulic cross sections will be taken at roughly 100' intervals and each cross section will be approximately 100' wide centered on the creek thalweg or will extend to top of channel bank, whichever results in a wider cross section. The hydraulic cross sections will be supplemented with LiDAR contours for the floodplain. Critical flood elevations will be surveyed for buildings located within the hydraulic survey limits and within approximately 250' of the creek thalweg.

4. **Right-of-Way (ROW) or Easement Plats:**

A total of three (3) ROW or easement plats are assumed for this project. This includes obtaining title searches for the three (3) plats.

5. **Preliminary Work Sheets:**

Create a Digital Terrain Model (DTM) to create the Plan & Profile sheet(s), Cross Sections and Alignment Drawings. The Plan and Profile drawings will be at a 1" = 50' scale. The Roadway Cross Sections will be cut at 50' increments.

6. **Bridge Condition Report (BCR):**

A BCR will be completed according to the BLRS Manual and the IDOT BCR Procedures & Practices Manual, including a Detailed Load Capacity Analysis for the existing piles.

**7. Preliminary Bridge Design and Hydraulic Report (PBDHR):**

A PBDHR will be completed according to the BLRS Manual and the IDOT Drainage Manual, 2011 Edition. The anticipated scope for the PBDHR is superstructure replacement of the existing three-span slab bridge. The PBDHR will include a HEC-RAS Scour Analysis (because the existing piers are founded on spread footings), a preliminary Type, Size and Location (TS&L) drawing, and a Joint Application Form for Floodway Permits. For superstructure replacement of the existing bridge, it is anticipated that US Army Corps of Engineers Nationwide Permit No. 14 and IDNR Office of Water Resources (OWR) Statewide Permit No. 12 will apply. The terms of Statewide Permit No. 12 will require a certification statement from both the City Engineer and Farnsworth Group, Inc. IDNR-OWR may assess a fee as high as \$5,000 prior to reviewing the Joint Application; this potential fee is not included in our fee.

**8. Environmental Study:**

The Environmental Study for this project will include an Environmental Survey Request (ESR), a Special Waste Screening, and a Preliminary Environmental Site Assessment (PESA) according to Chapter 20 of the BLRS Manual.

**9. Utility Coordination:**

Utility Coordination will include obtaining utility contact information through a Design Stage JULIE Locate request in conjunction with the ESR, and requesting location verification from JULIE member utilities in conjunction with the Preliminary PDR.

**10. Project Development Report (PDR):**

A PDR will be prepared according to Chapter 22 of the BLRS Manual. It is anticipated that this project will follow 3R Design Policy (Chapter 33 of the BLRS Manual) and will qualify as a Group I Categorical Exclusion (CE), requiring State approval and using IDOT form BLR 22211. Stage construction is anticipated. The City will provide crash data within the project limits from the past five (5) years for the Crash Analysis and any relevant records of Public Involvement for this project. Such investigations are to be made in accordance with the current requirements of the DEPARTMENT.
  - d.  Make or cause to be made such traffic studies and counts and special intersection studies as may be required to furnish sufficient data for the design of the proposed improvement.
  - e.  Prepare Army Corps of Engineers Permit, Department of Natural Resources-Office of Water Resources Permit, Bridge waterway sketch, and/or Channel Change sketch, Utility plan and locations, and Railroad Crossing work agreements.
  - f.  Prepare Preliminary Bridge design and Hydraulic Report, (including economic analysis of bridge or culvert types) and high water effects on roadway overflows and bridge approaches.
  - g.  Make complete general and detailed plans, special provisions, proposals and estimates of cost and furnish the LA with five (5) copies of the plans, special provisions, proposals and estimates. Additional copies of any or all documents, if required, shall be furnished to the LA by the ENGINEER at his actual cost for reproduction.
  - h.  Furnish the LA with survey and drafts in quadruplicate of all necessary right-of-way dedications, construction easement and borrow pit and channel change agreements including prints of the corresponding plats and staking as required.

- i.  Assist the LA in the tabulation and interpretation of the contractors' proposals

- (2) That all reports, plans, plats and special provisions to be furnished by the ENGINEER pursuant to the AGREEMENT, will be in accordance with current standard specifications and policies of the DEPARTMENT. It is being understood that all such reports, plats, plans and drafts shall, before being finally accepted, be subject to approval by the LA and the DEPARTMENT.
- (3) To attend conferences at any reasonable time when requested to do so by representatives of the LA or the Department.
- (4) In the event plans or surveys are found to be in error during construction of the SECTION and revisions of the plans or survey corrections are necessary, the ENGINEER agrees that he will perform such work without expense to the LA, even though final payment has been received by him. He shall give immediate attention to these changes so there will be a minimum delay to the Contractor.

  - b. Upon award of the contract for the improvement by the LA and its approval by the DEPARTMENT, 100 percent of the total fee due under the AGREEMENT based on the awarded contract cost, less any amounts paid under "a" above.

By Mutual agreement, partial payments, not to exceed 90 percent of the amount earned, may be made from time to time as the work progresses.

4. That, should the improvement be abandoned at any time after the ENGINEER has performed any part of the services provided for in paragraphs 1a, through 1h and prior to the completion of such services, the LA shall reimburse the ENGINEER for his actual costs plus \_\_\_\_\_ percent, **according to the attached Schedule of Charges**, incurred up to the time he is notified in writing of such abandonment - "actual cost" being defined as in paragraph 2 of THE LA AGREES.
5. That, should the LA require changes in any of the detailed plans, specifications or estimates except for those required pay the ENGINEER for such changes on the basis of actual cost plus \_\_\_\_\_ percent ~~to cover profit~~, overhead and readiness to serve, **according to the attached Schedule of Charges** - "actual cost" being defined as in paragraph 2 of THE LA AGREES. It is understood that "changes" as used in this paragraph shall in no way relieve the ENGINEER of his responsibility to prepare a complete and adequate set of plans and specifications.

#### **It is Mutually Agreed,**

1. That any difference between the ENGINEER and the LA concerning their interpretation of the provisions of this Agreement shall be referred to a committee of disinterested parties consisting of one member appointed by the ENGINEER, one member appointed by the LA and a third member appointed by the two other members for disposition and that the committee's decision shall be final.
2. This AGREEMENT may be terminated by the LA upon giving notice in writing to the ENGINEER at his last known post office address. Upon such termination, the ENGINEER shall cause to be delivered to the LA all surveys, permits, agreements, preliminary bridge design & hydraulic report, drawings, specifications, partial and completed estimates and data, if any from traffic studies and soil survey and subsurface investigations with the understanding that all such material becomes the property of the LA. The ENGINEER shall be paid for any services completed and any services partially completed in accordance with Section 4 of THE LA AGREES.
3. That if the contract for construction has not been awarded one year after the acceptance of the plans by the LA and their approval by the DEPARTMENT, the LA will pay the ENGINEER the balance of the engineering fee due to make 100 percent of the total fees due under this AGREEMENT, based on the estimate of cost as prepared by the ENGINEER and approved by the LA and the DEPARTMENT.
4. That the ENGINEER warrants that he/she has not employed or retained any company or person, other than a bona fide employee working solely for the ENGINEER, to solicit or secure this contract, and that he/she has not paid or agreed to pay any company or person, other than a bona fide employee working solely for the ENGINEER, any fee, commission, percentage, brokerage fee, gifts or any other consideration, contingent upon or resulting from the award or making of this contract. For Breach or violation of this warranty the LA shall have the right to annul this contract without liability.

IN WITNESS WHEREOF, the parties have caused the AGREEMENT to be executed in quadruplicate counterparts, each of which shall be considered as an original by their duly authorized officers.

**1. Right-of-Way (ROW) Survey:**
