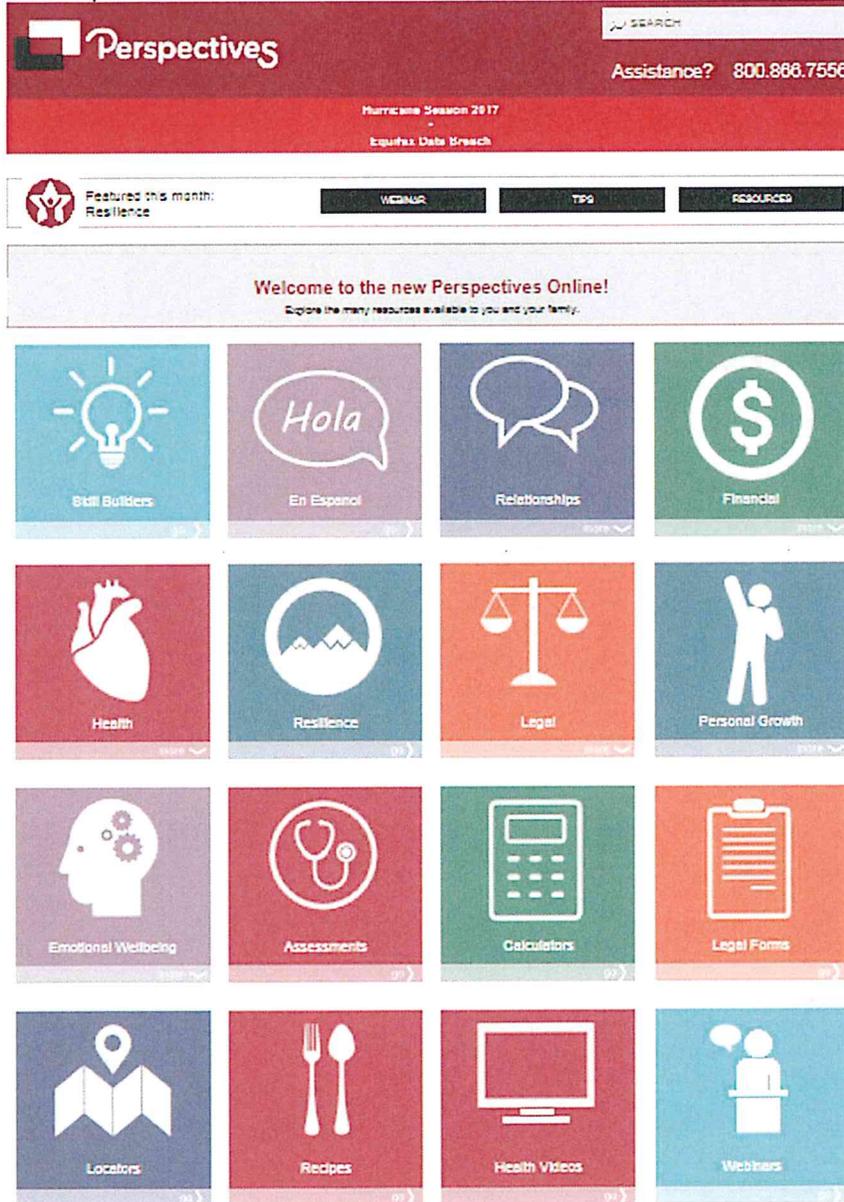

WHEREAS, pursuant to 65 ILCS 5/1-2.1-1 et seq. and 65 ILCS 5/11-31.1-1 et seq, the City has established an administrative adjudication system for addressing violations of City Code; and,

WHEREAS, pursuant to 5 ILCS 220/1 et seq., municipalities may enter into intergovernmental cooperation agreements for the establishment and maintenance of an administrative adjudication system; and,

WHEREAS, such intergovernmental cooperation agreements are beneficial to municipalities which could not otherwise establish and maintain their own separate systems; and,

WHEREAS, the Village of Alvin desires to enter into such an intergovernmental cooperation agreement with the City of Danville for the use of its already established system; and,

WHEREAS, the Village of Alvin has voted on and approved a proposed intergovernmental cooperation agreement; and,

WHEREAS, the City of Danville desires to assist the Village of Alvin through the use of the City's administrative adjudication system to address alleged violations of the Village of Alvin codes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DANVILLE, ILLINOIS as follows:

SECTION 1. The intergovernmental cooperation agreement, a copy of which is attached hereto and expressly made a part hereof, is approved and adopted.

SECTION 2. The Mayor and City Clerk are hereby authorized to execute and attest, respectively, the intergovernmental cooperation agreement on behalf of the City.

**INTERGOVERNMENTAL COOPERATION
AGREEMENT**

Between

**City of Danville, A Municipal Corporation
And
Village of Alvin, A Municipal Corporation**

This Intergovernmental Agreement is made and entered into as of the 7th day of May, 2019, but actually executed by each of the undersigned municipalities on the dates set forth beneath the respective signatures of their duly authorized officers below, by and between the City of Danville, Illinois, A Municipal Corporation (hereafter “Danville”) and the Village of Alvin, Illinois, A Municipal Corporation (hereafter “Alvin”), collectively the “Parties”.

The Parties hereto, as political subdivisions of the government of the State of Illinois, hereby agree, as permitted in 5 ILCS 220/1 et seq., to the following terms and conditions to define their responsibilities pursuant to the system of Administrative Adjudication set forth in 65 ILCS 5/1-2.1-1 et seq. and 65 ILCS 5/11-31.1-1 et seq .

WITNESSETH:

WHEREAS, Danville is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois; and,

WHEREAS, Alvin is a non-home rule unit of local government; and,

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/1-2.1-1 et seq. and 65 ILCS 5/11-31.1-1 et seq., provides home rule municipalities may establish a system of administrative adjudication for prosecuting certain violations of municipal ordinances; and,

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/1-2.2-1 et seq., provides non-home rule municipalities may establish a system of administrative adjudication for prosecuting certain violations of municipal ordinances; and,

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/1-2.2-10 provides that a municipality may establish a code hearing department within an existing code enforcement agency; and,

WHEREAS, Danville has established and is currently operating an administrative adjudication system for the prosecution of certain violations of Danville ordinances; and,

WHEREAS, Alvin desires to utilize an administrative adjudication system to prosecute certain violations of Alvin ordinances; and,

WHEREAS, the cost to establish an administrative adjudication system is substantial; and,

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., grants broad authority for units of local government to contract with one another to perform governmental services; and,

WHEREAS, Alvin desires to enter into an Intergovernmental Agreement with Danville to utilize Danville's Administrative Adjudication system; and,

WHEREAS, Danville will incur little or no additional expense in entering into such an agreement.

NOW, THEREFORE, in consideration of the matters set forth above, the agreements, covenants, representations and undertakings made and contained in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Danville and Alvin hereby agree, covenant, represent and undertake as follows:

ARTICLE I
Administration and Staff

- A. Danville's Code Hearing Department shall act as the Code Hearing Department for Alvin.
- B. Danville's Hearing Officers shall act as Hearing Officers for Alvin and conduct those hearings necessary to carry out the purposes of the administrative adjudication system regarding those matters involving Alvin.
- C. Any employees or agents assigned to the Hearing Officers by Danville shall continue to act in such capacity regarding those matters involving Alvin.
- D. Danville shall have the sole authority with regard to decisions concerning the operation of the administrative adjudication system, including the date, time and location of hearings.
- E. Alvin shall have the sole authority over the disposition of the matters referred to Danville's Code Hearing Department.

ARTICLE II

Personnel

- A. Police Officers and all other employees of Alvin involved in enforcing the ordinances of Alvin shall be available to be called as witnesses on any matter involving Alvin.
- B. Employees of Danville and Alvin shall be at all times employees of their respective municipality and shall retain all of the rights, privileges, immunities, and benefits pursuant to such employment.

ARTICLE III

Collection and Distribution of Funds

- A. Danville shall collect and hold all money to be paid toward any penalties imposed on a matter related to Alvin.
- B. At the end of each month, Danville shall cause to be issued a check, payable to Alvin, for those funds collected and applied toward the fines imposed on matters related to Alvin.
- C. All funds collected and applied toward costs and fees shall be kept by Danville. Said funds shall act as reimbursement for the costs and fees incurred by Danville for prosecuting ordinance violation cases for Alvin.

ARTICLE IV

Procurement, Records, Audits

- A. Danville shall keep accurate records of all matters pursued on behalf of Alvin, which shall include disposition of the cases, any penalties imposed, and any payments made toward the penalties imposed.
- B. Alvin may request copies of those records pertaining to matters prosecuted on behalf of Alvin.
- C. Alvin may request an audit of Danville's records with regard to cases and funds received pertaining to matters prosecuted on behalf of Alvin.
- D. Danville shall be the sole authority regarding procurement of any items, such as equipment, software, or personnel, related to the administrative adjudication system currently operated by Danville.

ARTICLE V
Professional and Technical Support Services

- A. Danville shall be the sole authority in obtaining Professional Support Services. This may include obtaining the services of outside counsel to assist the City Attorney in prosecuting cases within the administrative adjudication system.
- B. Danville shall be the sole authority in obtaining Technical Support Services to assist in issues affecting matters within the administrative adjudication system.

ARTICLE VI
General Provisions

- 1. Review, Modifications. Neither this Agreement nor any provisions hereof may be changed, revised, modified, waived, discharged, terminated or otherwise abrogated, diminished or impaired other than by an instrument in writing duly authorized and executed by both Parties. The Parties shall review the terms and conditions of this Agreement annually. They shall do so in time to permit any changes which may be necessary to provide for effective operation at the commencement of the next fiscal year. Any amendments to the Agreement, whether as modifications to the existing terms and conditions hereof or as additions hereto, shall be reduced to writing and shall become effective only when signed by the Parties.
- 2. Notices, Communications. All notices, demands, request for records, requests for funds, or other communications under or in respect of this Agreement shall be in writing and shall be deemed to have been given when the same are (i) deposited in the United States mail and sent by first class mail, postage prepaid or (ii) delivered, in each case, to Danville or Alvin at their respective addresses (or at such other address as each may designate by notice to the other), as follows:
 - (1) if to Danville, at the City of Danville, Robert E. Jones Municipal Building, 17 West Main St., Danville, Illinois 61832, Attn: Mayor; and,
 - (2) if to Alvin, at Village of Alvin, PO Box 169, Alvin, IL 61811
Attn: Mayor.
- 3. Term and Termination. This Agreement shall automatically be renewed for a period of one year each May 1, unless not less than 90 days prior thereto one of the Parties hereto shall, in writing, have notified the other Party that it shall deem this agreement to be terminated on the impending April 30.

LEASE

THIS LEASE is made and executed in duplicate on the 3rd day of June, 2014, by and between the City of Danville, an Illinois Municipal Corporation ("Landlord"), and Vermilion Advantage, an Illinois Not-for-profit ("Tenant").

ARTICLE I PREMISES

1.1 Premises. Landlord owns, in fee simple, title to the land described on Exhibit A attached hereto upon which is located a commercial building ("Building"), parking areas, and other appurtenances located at 17 W. Main Street, Danville, Illinois (collectively, the "Property"). Landlord hereby leases for the Term, at the rental and upon all the conditions set forth herein, to Tenant _____ square feet of space in the Building, including a right of ingress and egress over the adjoining areas of the Building for an emergency exit and the right to use the parking areas, (the "Premises"), for use by Tenant as office space and for no other purpose without the express written consent of Landlord.

Landlord may construct, improve and alter the Building from time to time as Landlord chooses, other than the Premises, but it is not obligated to do so unless otherwise provided for in this Lease.

1.2 Use Covenants. Landlord covenants, represents and warrants that, as of the Commencement Date (hereinafter defined), the Building and Premises shall comply with all applicable statutes, ordinances, rules, regulations, orders and restrictions of record.

ARTICLE II TERM

The Term of this Lease shall commence on the 1st day of July, 2014 ("Commencement Date") and shall end at 11:59 p.m. on June 30, 2019. Upon the expiration of the Term, Landlord and Tenant may enter into extensions for two additional 5-year terms, provided neither Landlord nor Tenant gives the other written notice of intent to terminate this Lease thirty (30) days prior to the expiration of the then current term. Such written extension agreements shall be upon the same terms, covenants, and conditions as provided herein for the original term, unless otherwise modified by the Parties within the written extension agreement.

Tenant must surrender the Premises to Landlord immediately upon expiration or termination of this Lease and is liable to Landlord for one and one-half times the Rent during any period of holdover after termination.

ARTICLE III
RENT

3.1 Payment of Base Rent. From and after the Commencement Date until the expiration of the Term, as extended from time-to-time, rent shall be payable in monthly installments of \$300.00 on the first day of each month during the Term. Rent shall be payable in lawful money of the United States to Landlord at the address stated herein for notices or to such other persons or at such other places as Landlord may designate in writing.

3.2 Gross Rent. Rent is inclusive of all amounts payable by Tenant hereunder, including base rent, general real estate taxes, insurance and utilities for the Premises, and Tenant is not required to pay any other amounts pursuant to this Lease, other than Tenant's payments for maintenance as provided in Article VI herein, insurance as provided in Article VII herein, and utilities as provided in Article X herein.

3.3 Payment on Account. Any payment by Tenant or acceptance by Landlord of a lesser amount than due will be treated as a payment on account. The acceptance by Landlord of a check for a lesser amount with an endorsement or statement on the check or on any letter accompanying such check that such lesser amount is payment in full will be given no effect, and Landlord may accept such check without prejudice to any other rights or remedies which Landlord may have under the provisions of this Lease.

ARTICLE IV
USE

4.1 Use and Restrictions. The Premises may be used and occupied for general office use.

4.2 Compliance with Law. Tenant shall, at its sole cost and expense, comply with all applicable statutes, ordinances, rules and regulations, if any, in effect during the Term, as extended from time-to-time, regulating or pertaining to Tenant's specific use of the Premises. Notwithstanding the foregoing or any other provisions of this Lease to the contrary, Tenant shall not be obligated to make any changes, modifications or alterations to the Premises in order to cause the same to comply with any applicable statute, ordinance, rule or regulation which does not apply to its specific use of the Premises. Tenant will promptly comply with and execute all such rules, orders and regulations for prevention of fires, at its own expense. Tenant will not permit the Premises to be occupied for any purpose deemed disreputable or deemed to be extra-hazardous on account of fire.

ARTICLE V
DELIVERY OF THE PREMISES

5.1 Pre-Existing Building Conditions. Landlord and Tenant acknowledge and agree the items set forth on Exhibit B attached hereto and incorporated herein by this reference (the “Pre-Existing Building Conditions”) are in various states of repair as of the Commencement Date at no fault of Tenant, but such conditions do not render the Premises uninhabitable. Landlord agrees, at its sole cost and expense, to be responsible for repair and/or replacement, if necessary of all such Pre-Existing Building Conditions, and shall include such repairs/replacements in its long-term maintenance plans for the Property, covenanting only that such conditions shall not render the Premises uninhabitable during the Term, as extended from time-to-time.

5.2 Tenant Signs. Any signage on the Building desired to be installed by Tenant is subject to Landlord’s consent, which shall not be unreasonably withheld. Tenant’s installation of signage on the Premises and/or the Building shall conform to all municipal ordinances or other laws and regulations applicable thereto.

ARTICLE VI
MAINTENANCE, REPAIRS AND ALTERATIONS

6.1 Landlord’s Obligations. During the Term, as extended from time-to-time, Landlord will maintain the exterior of the Building and adjacent areas in good condition. Landlord will make all exterior repairs, including repairs to the structural supports, exterior supports, foundation of the Building, all utilities serving the Building, including without limitation, heating and ventilation, electrical, gas, water, storm and sanitary sewer lines and systems, the roof, as well as repairs as required because of water entering the Premises from the roof or other parts of the Building or from other causes not under Tenant’s control. Provided, however, Landlord shall not be required to make such repairs necessitated by either the negligence or willful misconduct of Tenant, its agents, employees, contractors, invitees, or sublessees.

6.2 Tenant’s Right to Cure Landlord’s Maintenance and Repair Defaults. Notwithstanding anything to the contrary contained in this Lease, if Landlord shall fail to commence to perform any of its repair or maintenance obligations required to be performed by Landlord under paragraph 6.1 above and does not cure such default within thirty (30) days after written notice from Tenant specifying the default, Tenant, without waiver of or prejudice to any other right or remedy it may have, shall have the right to perform such repairs and maintenance for Landlord, and deduct from the Rent next due Landlord any amounts incurred by Tenant for such repairs. Notwithstanding anything to the contrary herein, in the event of emergencies or where necessary to prevent personal injury or physical damage to the Premises, Tenant may proceed to take such immediate action without notice to the Landlord in order to eliminate or lessen the risk of personal injury or damage to the Premises.

6.3 Tenant's Obligations. During the Term, as extended from time-to-time, Tenant will make all necessary repairs to the interior of the leased Premises and to maintain the interior in good condition.

All sums payable by Tenant under this paragraph are deemed to be rent and, if not paid, Landlord will have with respect to such sums all rights and remedies provided for in this Lease and by law for non-payment of rent.

6.4 Alterations and Additions.

(a) Tenant may make any interior, nonstructural alterations to the Premises it desires without Landlord's consent, provided that the same will not adversely affect the building systems or structure. All other alterations to the Premises shall require Landlord's consent, which shall not be unreasonably withheld.

(b) Tenant shall pay, when due, all claims for labor or materials furnished or alleged to have been furnished to or for Tenant at or for use in, on or about the Premises, which claims are or may be secured by any mechanics or materialmen's lien against the Premises or any interest therein; provided, however, Tenant may, in good faith, contest the validity of any such lien, claim or demand, and, if so, then Tenant shall, at its sole cost and expense, defend itself and Landlord against the same and shall pay and satisfy any adverse judgment that may be rendered thereon before the enforcement thereof against Landlord or the Premises.

(c) All alterations, improvements and additions, which may be made in, on or about the Premises, shall become the property of Landlord and remain on and be surrendered with the Premises at the expiration of the Term, as extended from time-to-time. The foregoing to the contrary notwithstanding, Tenant's merchandise, machinery, furniture, trade fixtures, equipment, movable partitions, and other personal property other than that which is permanently affixed to the Premises so it cannot be removed without material damage to the Premises, shall remain the property of Tenant and may be removed by it provided it repairs any damage caused by such removal.

ARTICLE VII
INSURANCE AND INDEMNITY

7.1 Tenant's Insurance. Tenant shall, at Tenant's sole cost and expense, cause to be placed in effect immediately upon commencement of the Term and shall maintain in full force and effect during the Term or any extension thereof the following types of insurance:

(1) insurance written with a company acceptable to Landlord covering all contents of the Premises, including all property being warehoused or stored by Tenant, on a full replacement cost basis (no deduction for depreciation), insuring against all risks of direct physical loss and excluding only such unusual perils as nuclear attack, earth movement, flood and war; and

(2) commercial general liability insurance, on an occurrence basis, insuring against claims for bodily injury or death and for damage to property, occurring in or about the Premises, for limits of not less than One Million Dollars (\$1,000,000.00) single occurrence limit and Two Million Dollars (\$2,000,000.00) aggregate limit. Such policy or policies of insurance shall be from a company authorized to do business in the State of Illinois and shall name Landlord as an additional insured.

All sums paid by Tenant under this paragraph are deemed to be rent and, if not paid, Landlord will have with respect to such sums all rights and remedies provided for in this Lease and by law for non-payment of rent.

7.2 Landlord's Insurance. Landlord shall carry a policy of general liability property insurance on the Building (including the Premises) in the amount of the full replacement value thereof exclusive of grading, footings and foundations. Landlord shall carry, at Landlord's sole cost and expense during the Term, commercial general liability insurance, on an occurrence basis, insuring against claims for bodily injury or death and for damage to property, occurring in or about the Building and common areas, for limits of not less than One Million Dollars (\$1,000,000.00) single occurrence limit and Two Million Dollars (\$2,000,000.00) aggregate limit.

7.3 General Insurance Requirements.

(a) All insurance required of Tenant under paragraph 7.1 above shall also be obtained and maintained by each of Tenant's sublessees, and all such subleases shall specifically require each sublessee to maintain all such insurance, waive subrogation rights as provided by paragraph 7.4 below, and indemnify Landlord as provided by paragraph 7.4 below.

(b) All insurance to be kept in force hereunder shall name Landlord, Tenant and any sublessee of the Premises as named insureds thereunder.

(c) Each party and sublessee shall deliver certificates of the insurance required to be carried hereunder to the parties to this Lease on or before the date of this Lease.

(d) All policies of insurance shall be non-assessable and shall provide that the same may not be cancelled or materially altered without at least thirty (30) days prior written notice to the parties hereto and that such insurer waives any rights of subrogation against the parties hereto and its respective employees, agents and representatives.

7.4 Waiver of Subrogation. Landlord and Tenant hereby waive the rights each may have against the other on account of any loss or damage occasioned to Landlord's or Tenant's respective property, or the Premises, or arising from any risk insured against (or required to be insured against) by Landlord or Tenant; and the parties each, on behalf of their respective insurance companies insuring the property of either Landlord or Tenant against any such loss, waive any right of subrogation that they may have against

Landlord or Tenant, as the case may be. The release set forth in this paragraph shall apply only to the extent that such loss or damage is covered by insurance, or would have been covered by insurance required to be carried hereunder, if a party fails to carry the required insurance. Landlord and Tenant agree to use due diligence to obtain any necessary endorsement on any insurance policies in order to obtain the result desired under this paragraph, including, without limitation, waiver of subrogation rights.

7.5 Tenant's Indemnification of Landlord. Tenant shall indemnify, defend (by counsel reasonably acceptable to Landlord), protect, and hold Landlord, Landlord's partners, members, officers, directors, managers, employees, authorized agents, contractors, visitors and invitees (collectively, "Landlord's Indemnified Parties"), harmless from and against all claims, liabilities, penalties, losses, damages, costs and expenses, claims or judgments (including, without limitation, attorney's fees) in connection with or arising out of any injury to persons or damage to property occurring on the Premises which is directly related to and proximately caused by Tenant or Tenant's employees, agents, sublessees or contractors, or arising from Tenant's use, maintenance, occupation or operation of the Premises; provided, however, Tenant shall not indemnify Landlord for any injury or damage to the extent arising as the result of the negligence or willful misconduct of Landlord or Landlord's Indemnified Parties. Landlord need not have first paid any such claim in order to be defended or indemnified.

7.6 Landlord's Indemnification of Tenant. Landlord shall indemnify, defend (by counsel reasonably acceptable to Tenant), protect, and hold Tenant, Tenant's directors, officers, members, managers, employees, authorized agents, contractors, sublessees, visitors or invitees (collectively, "Tenant's Indemnified Parties"), harmless from and against all claims, liabilities, penalties, losses, damages, costs and expenses, claims or judgments (including, without limitation, attorneys' fees) in connection with or arising out of any injury to persons or damage to property occurring on the Premises which is directly related to and proximately caused by the Landlord or Landlord's employees, contractors, tenants or agents. Provided, however Landlord shall not indemnify Tenant for any injury or damage to the extent arising as the result of the negligence or willful misconduct of Tenant or Tenant's Indemnified Parties. Tenant need not have first paid any such claim in order to be defended or indemnified.

ARTICLE VIII DAMAGE OR DESTRUCTION

If the Premises are damaged or destroyed in whole or in part by fire or other casualty during the Term as extended from time-to-time, Landlord will, with due diligence, repair, restore, rebuild or replace the Premises or the portion destroyed or damaged, so that the Property is substantially the same as it was prior to such damage. If the destruction or damage amounts to more than fifty percent (50%) of the insurable value of the Premises, Landlord is entitled to cancel and terminate this Lease by giving written notice to Tenant within thirty (30) days after the date such damage or destruction has occurred. In such event, this Lease terminates on the date specified in such notice, and Landlord is not obligated to repair or rebuild. In the event of such damage or

destruction, Rent will be abated for the time during which, and to the extent to which, the Premises may not be used by Tenant for business purposes. Tenant will be entitled to receive a pro rata refund out of any advance rent paid by it for the period during which the Premises were unusable by reason of destruction or damage.

ARTICLE IX TAXES

9.1 Real Estate Taxes. Tenant shall pay, prior to delinquency, all general real estate taxes and assessments applicable to the Property, whether foreseen or unforeseen, during the Term, as extended from time-to-time. All such payments shall be made prior to the applicable delinquency date.

9.2 Personal Property Taxes. Tenant shall pay, prior to delinquency, all taxes assessed against and levied on trade fixtures, furnishings, equipment and all other personal property of Tenant in the Premises, if any. When possible, Tenant shall cause said trade fixtures, furnishings, equipment and all other personal property to be assessed and billed separately from the real property of Landlord.

ARTICLE X UTILITIES

10.1 Services Provided. Landlord shall provide the following utility services to the Premises during the Term, as extended from time-to-time: water, sewer, gas, heat, light, power, and trash collection.

10.2 Interruption in Services. Tenant understands, acknowledges and agrees any one or more of the Utilities may be interrupted by reason of accident, emergency or other causes beyond Landlord's control, or may be temporarily discontinued or diminished temporarily by Landlord or other persons until certain repairs, alterations or improvements may be made; and, any such interruption or change shall not be deemed an eviction or disturbance of Tenant's right to possession, occupancy and use of the Premises or any part thereof, or render Landlord liable to Tenant for damages (except as provided herein). Notwithstanding anything to the contrary in this paragraph, if any Utility is interrupted and such interruption continues for more than forty-eight (48) hours after receipt of notice from Tenant, the cure for which is within Landlord's reasonable control, all Rent and other amounts due hereunder, if any, shall abate until such service is restored. Landlord will use its best efforts to restore interrupted services upon notice from Tenant of the interruption of service.

ARTICLE XI
ASSIGNMENT AND SUBLETTING

11.1 Landlord's Consent Required.

(a) Tenant shall not assign, transfer, mortgage, sublet or otherwise transfer or encumber all or any part of Tenant's interest in this Lease or in the Premises, without Landlord's prior written consent, which Landlord shall not unreasonably withhold or delay. Landlord may condition its consent upon the payment of additional rent.

(b) Notwithstanding anything in this Lease to the contrary, Tenant may, without the consent of Landlord, assign this Lease or sublet the base square footage of the Premises to any parent, subsidiary or affiliate of Tenant or to any person or entity which acquires (by purchase, merger or consolidation) Tenant's business operated on the Premises.

11.2 No Release of Tenant. Regardless of Landlord's consent, no subletting or assignment shall release Tenant of Tenant's obligations hereunder or alter the primary liability of Tenant to pay the Rent and to perform all other obligations to be performed by Tenant hereunder.

ARTICLE XII
DEFAULTS; REMEDIES

12.1 Default by Tenant. (a) The occurrence of any one or more of the following events shall constitute a default of this Lease by Tenant:

(i) The failure by Tenant to make any payment of Rent or Additional Rent or any other payment required to be made by Tenant hereunder, as and when due, where such failure shall continue for a period of ten (10) days after written notice thereof from Landlord to Tenant; and

(ii) The failure by Tenant to observe or perform any of the covenants, conditions or provisions of this Lease to be observed or performed by Tenant, other than described in subparagraph 12.1(a)(i) above, where such failure shall continue for a period of thirty (30) days after written notice thereof from Landlord to Tenant; provided, however, if the nature of Tenant's failure to perform is such that more than thirty (30) days are reasonably required for its cure, then Tenant shall not be deemed to be in default if Tenant commences such cure within said thirty (30) day period and thereafter diligently pursues such cure to completion.

(b) Should default be made in the payment of Rent or Additional Rent, or in the payment of any other amount payable hereunder by Tenant, or should Tenant violate or fail to perform any other term, condition or covenant on its part to be performed hereunder, or should Tenant vacate or abandon the Premises or any part thereof contrary to the terms and provisions of this Lease, Landlord may, at its option, at any time after

the expiration of the default periods provided in subparagraph 12.1(a) above, reenter and retake possession of the Premises at the highest rental obtainable and at Landlord's option, either terminate and cancel this Lease or apply the proceeds that may be obtained from any reletting, after deduction of necessary costs and expenses with regard to retaking the possession and reletting of the Premises, to the Rent and shall be entitled to hold Tenant liable for any balance of Rent which may remain from time to time unsatisfied and unpaid. Until the Premises have been relet, Tenant will pay to Landlord on the same day as Rent payments are due, the actual damages suffered by Landlord since the last payment, either Rent or damages, was made. After the Premises have been relet, Tenant will pay to Landlord, on the last day of each month, the difference between the Rent received for the period from reletting and the Rent reserved under this Lease for that month.

Landlord shall be entitled to reasonable attorney fees incurred by virtue of any of Tenant's acts of default. Landlord shall have the right from time to time in any court of competent jurisdiction to sue for and recover from Tenant the amount of unpaid Rent due hereunder, taking into account any other rent derived from the reletting of the Premises by Landlord pursuant to the terms of this paragraph.

12.2 Default by Landlord. (a) Landlord shall be in default hereunder if Landlord fails to observe or perform any of the covenants, conditions, or provisions of this Lease to be observed or performed by Landlord when such failure shall continue for thirty (30) days after written notice thereof from Tenant to Landlord; provided, however, if the nature of Landlord's obligation is such that more than thirty (30) days are required for its cure, then Landlord shall not be deemed to be in default if Landlord commences such cure within said thirty (30) day period and thereafter diligently pursues such cure to completion.

(b) Should default be made by Landlord with regard to any of the terms, conditions and provisions of this Lease, then Tenant, at Tenant's option, at any time after the expiration of the default period provided under subparagraph 12.2(a) above, correct said default or defaults and deduct the cost thereof from the Rent next due Landlord, or terminate this Lease and recover from Landlord such sums and damages as a court of competent jurisdiction may award, including reasonable attorney fees.

ARTICLE XIII MISCELLANEOUS PROVISIONS

13.1 Severability. The invalidity of any provision of this Lease as determined by a court of competent jurisdiction shall in no way affect the validity of any other provision hereof.

13.2 Captions. Article and paragraph captions are not a part hereof.

13.3 Indemnities. All indemnities herein shall survive expiration or termination of this Lease.

13.4 Incorporation of Prior Agreements; Amendments. Landlord and Tenant acknowledge and agree that as between them there are no terms, conditions, covenants, obligations, representations or warranties, express or implied, forming a part of or in any way affecting or relating to this Lease, except as expressly set forth herein, and this Lease constitutes the entire agreement between them. This Lease may be modified only by a writing executed by Landlord and Tenant.

13.5 Notices. Any notice required or permitted to be given hereunder shall be in writing, and may be given by personal delivery, by certified mail, return receipt requested, or by reliable overnight courier and shall be deemed received when (i) if personally delivered, upon receipt; (ii) if sent by certified mail, upon acceptance or rejection of the certified mail; or (iii) if by overnight courier, on the next business day following the date sent, and addressed to Tenant or to Landlord at the addresses noted below:

Either party may, by notice to the other, specify a different address for notice purposes.

13.6 Waivers. No waiver by Landlord of any provision hereof shall be deemed a waiver of any other provision hereof or of any subsequent breach by Tenant of the same or any other provision. Landlord's consent to or approval of any act shall not be deemed to render unnecessary the obtaining of Landlord's consent to or approval of any subsequent act by Tenant. The acceptance of the Rent by Landlord shall not be a waiver of any preceding breach by Tenant of any provision hereof, other than the failure of Tenant to pay the particular Rent so accepted, regardless of Landlord's knowledge of such preceding breach at the time of acceptance of such Rent.

13.7 Cumulative Remedies. No remedy or election hereunder shall be deemed exclusive but shall, wherever possible, be cumulative with all other remedies at law or in equity.

13.8 Binding Effect; Choice of Law. This Lease shall bind the parties, their personal representatives, successors and assigns. This Lease shall be governed by the laws of the State of Illinois.

13.9 Title, Quiet Enjoyment, Non-Disturbance and Subordination. Landlord covenants and represents it is the sole owner of the Building and the Property in fee

simple and has the right and authority to enter into, execute and deliver this Lease; and does further covenant that Tenant upon paying the Rent and performing the conditions and covenants herein contained, shall and may peaceably and quietly have, hold and enjoy the Premises for the Term, as extended from time-to-time.

13.10 Landlord's Right to Show and Advertise Premises. Tenant will permit Landlord or Landlord's agents to show the Premises to persons wishing to hire or purchase the Premises; Landlord or its agents is entitled to place notices on the Premises, offering the Premises "To Let" or "For Sale," and Tenant will permit the notices to remain without molestation.

13.11 Attorney's Fees. If either party herein brings an action to enforce the terms hereof or declare rights hereunder, the prevailing party in any such action, on trial or appeal, shall be entitled to reasonable attorneys' fees and costs to be paid by the losing party as fixed by the court.

13.12 Corporate Authority. Each individual executing this Lease on behalf of Landlord and Tenant represents and warrants that he or she is duly authorized to execute and deliver this Lease on behalf of said party by the authority of such entity and this Lease is binding upon said party in accordance with its terms.

13.13 Force Majeure. Except as provided otherwise in this Lease, Landlord and Tenant shall be excused from performing any obligation under this Lease (except the payment of the Rent or other monetary obligations), and any delay in the performance of any obligation under this Lease shall be excused, if and so long as the performance of the obligation is prevented, delayed or otherwise hindered by acts of God, fire, earthquake, floods, explosion, acts of the elements, war, riots, mob violence, inability to procure or a general shortage of skilled labor, equipment, facilities, materials or supplies in the open market, failure of transportation, strikes, lockouts, actions of labor unions, condemnation, court orders, laws or orders of governmental or military authorities or any other cause, whether similar or dissimilar to the foregoing, not within the control of the parties hereto.

13.14 Time of the Essence. Time is of the essence for each and every provision, covenant, and condition contained in this Lease and on the part of Tenant or Landlord to be done and performed.

ARTICLE XIV
BROKERS

Each party warrants to the other that each party has had no dealings with any broker in connection with this Lease, and indemnifies and hold harmless the other party from any and all claims for commissions and other fees and expenses (including reasonable attorney's fees) arising from a breach of the foregoing warranty.
